WHEREAS, under Rule 23(h) of the Federal Rules of Civil Procedure, this matter came before the Court on the motion of Plaintiffs for award of Attorneys' Fees and Expenses and Plaintiffs' Incentive Awards pursuant to the agreement of

the Parties in the Settlement Agreement dated February 21, 2020 and filed as ECF No. 93-4 ("Settlement Agreement");<sup>1</sup> and

WHEREBY, the Court having considered all papers filed and proceedings conducted herein, and good cause appearing therefor, it is hereby ORDERED as follows:

- 1. The Court, after careful review of Class Counsel's papers, finds the requested attorneys' fees and expenses to be reasonable and, therefore, grants Class Counsel's request for attorneys' fees and expenses in the amount of \$1,800,000.

- 3. The Court directs the foregoing payments to be made according to the Parties' agreement in the Settlement Agreement, ECF No. 93-4, at ¶¶ 88-93.
